

**COVID-19 Waiver of Liability**

This agreement relates to my, or my minor child's, presence on the Levine Music Campuses. I, acknowledge and agree, on my behalf or on behalf of my minor child to the following.

By signing this agreement, I acknowledge that I and / or my minor child may be exposed to COVID-19 (novel coronavirus) and / or a mutation or variation thereof ("COVID-19"), while on the Levine Campus and that such exposure may include the risk of infection of COVID-19, which may result in severe illness, permanent disability and / or death. I acknowledge the contagious nature of COVID-19 and that the Centers for Disease Control and Prevention and other state and local public authorities ("Authorities") recommend or mandate social distancing, use of face covers, and other measures to help mitigate the spread of COVID-19. I further acknowledge that Levine Music has put in place preventative measures to reduce the spread of COVID-19. I further acknowledge that Levine Music cannot guarantee that I (or my minor child, if applicable) will not become infected with COVID-19. I understand that the risk of becoming exposed to and / or infected by COVID-19 may result from the actions, omissions, or negligence of myself (including my minor child, if applicable) and others, including, but not limited to Levine Music employees, contractors, volunteers, and other clients and their families. I voluntarily seek access to Levine Music, voluntarily seek to participate in the Activity (for myself or my minor child), and acknowledge that I (or my minor child, if applicable) am increasing my / his / her risk of exposure to COVID-19 by access to the Campuses . I voluntarily assume all risk to my health, or that of my minor child, if applicable, that may result due to participation in the Activity.

I acknowledge that I (and my minor child, if applicable) must comply with all COVID-19-related policies, procedures, mandates, and other requirements set forth by both the Authorities and the Levine Music while on the Campuses and on property owned by, used by, or operated by Levine Music for purposes of participating in the Activity.

I hereby release and agree to hold Levine Music, its trustees, officers, directors, managers, employees, volunteers, agents, and representatives (each a "Releasee") harmless from, and waive on behalf of myself, and on behalf of my minor child if applicable, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses (including attorneys' fees) and compensation for damage or loss to myself, my minor child, and/or property that may be caused by any act, or failure to act of a Releasee, or that may otherwise arise in any way in connection with any services received from a Releasee. I understand that this release discharges the Releasees from any liability or claim that I or my minor child, my heirs, or any personal representatives may have against them with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from a Releasee. This release does not apply to any intentional or willful acts on the part of a Releasee.
